Parent/Student Covenant

Sunbury Christian Academy (SCA) is a religious institution providing an education in a distinctly Christian environment. The biblical and philosophical goal of SCA is to develop students into mature, image bearers of God, who are able to live a Christ-like life. By necessity, this defines the school’s understanding and belief of what qualities or characteristics exemplify a Christ-like lifestyle and guide student behavioral expectations. Even though parents and students may be non-Christians and hold different doctrine while enrolled at SCA, all students are expected to exhibit the qualities of a Christ-like life espoused and taught by the school, and are expected to refrain from what SCA leadership defines as non-biblical activities or behaviors. On those occasions in which the conduct of a student is counter to or in opposition of the biblical lifestyle SCA expects, SCA reserves the right, within its sole discretion, to refuse admission of an applicant or to discontinue enrollment of a student. Such non-Biblical behavior includes, but is not limited to:

- Participating in or condoning sexual immorality, homosexual acts or sexual orientation; promoting such practices; or otherwise the inability to support the moral principles of the school (Leviticus 18:22, Romans 1:24-28, 1 Corinthians 6:9, Matthew 19:4-6).
- Using or distributing tobacco products, illegal drugs, or alcohol (1 Corinthians 6:19-20, Titus 3:1)
- Cheating, lying, or stealing (Proverbs 28:6; 12:22; 19:1, Colossians 3:9, Exodus 20:15, Exodus 22:1-31)
- Using profanity and obscenity in word or action (Exodus 20:7, Ephesians 4:29, Galatians 5:19-21, Timothy 2:16) 2
- Ongoing dress code violations (1 Timothy 2:9, 1 Peter 3:3-4, 1 Corinthians 6:19-20, Romans 12:1-2)
- Destroying school property (Philippians 2:4)
- Talking disrespectfully to school personnel or any other type of insubordination (Romans 13:1-7)
- Inappropriate body contact or public displays of affection (Romans 12:1; 13:13)
- Harassing/bullying others (Leviticus 19:18, Mark 12:31, Luke 6:31, Romans 12:18, Philippians 2:3, 1 Peter 3:8-9, 1 John 3:15)
- Involvement in any illegal activity (Romans 13:1-5)

“I appreciate and respect the standards of SCA, and I agree to cooperate with SCA school standards as stated above. I will avoid all non-Biblical behavior and hereby agree to support all regulations of the school on the applicant’s behalf and authorize SCA to employ such discipline, as it deems wise and expedient for the education and training for my child.”

Application, Interview, and Registration Procedures:

Please submit a current transcript or report card copies for the last two school years and any achievement or ability test results for each child applying.

An interview will be scheduled with the administrator after your application, academic records, and discipline history have been evaluated. The interview will be conducted with at least one parent/guardian and student.

A \$50 registration, testing, and interview fee must be paid with the application and is non-refundable.

For your convenience in meeting your financial obligations, tuition is divided into 12 installments. The first payment is due July 1, the last payment is due by May 30. A 2% discount is given if entire annual tuition is paid before July 6.

Payment Options:

1. We will pay our tuition monthly. Twelve monthly installments: First payment due on/before July 1 and the last payment due on/before May 30.
2. We will pay our total tuition on/ before July 5 (2% discount)
3. My child will be attending K4
 - Part time – 3 full days, Tuesday, Wednesday, Thursday
 - Full time – 5 full days, Monday – Friday
